ORDER

On recommendations of Review DPC held on 25/10/2019, the Competent Authority is pleased to accord the approval for promotion of following Assistant Teacher working in MCD on regular basis to the post of TGT/TGT(MIL) pertaining to the year 2011-12 in the pay scale of Rs. 9300-34800/-+Grade Pay 4600/- (Pre-revised) plus usual allowances as admissible.

The promotion is subject to the condition that the teachers fulfil all the requirements as laid down in the Recruitment Rules of TGT/TGT (MIL) of this Directorate and is further subject to the condition that *there is no vigilance case/departmental enquiry pending or no penalty is in operation against the teacher concerned at any level.*

If the teacher does not accept the promotion, no offer of promotion will be provided to him/her for a period of one year from the date of refusal or till the next vacancy occurs, whichever is later. If the reasons given by the teacher for his/her refusal for promotion are not acceptable to the Appointing Authority, then this Department may enforce the promotion of the teacher and in case the teacher still refuses to accept the promotion, disciplinary action can be taken against him/her for refusal. Teacher refusing promotion and debarred consequently will lose his seniority, if promoted later.

The Director (Primary Education) North DMC is hereby requested to direct the above teacher to contact Estt-III Branch of this Directorate at Room No. 222 Old Sectt. Delhi - 110054 by 15/12/2019 for submission of her willingness to join the promotional post, verification of educational qualification documents. Further, fresh VCR, IC and WC are also requested to be submitted. Failing this her promotion shall be treated as cancelled with retrospective effect without any further information. No application/request will be entertained at any level.



Further, the date of promotion of the aforesaid teacher may be treated with effect from the date of promotion of her immediate junior promoted to the post of TGT (N.Sc) vide this Directorate's order No. 2 dated 11/12/2012 with all the consequential benefits except payments of any back wages. The seniority of TGT/TGT (MIL) will be assigned as per rules. Monetary benefits of the promotion will accrue from the date of joining to the post of TGT/TGT (MIL) in this Directorate.
