**ORDER**

Whereas, **Mr./Ms. NISHAN SINGH D.O.B.04.10.1990, Roll No. 120214200010** has been nominated by the DSSSB for the post of **TGT (PUNJABI) MALE** against Post Code **142/17** vide letter **F.NO.1(397)/DSSSB/P&P/2017/2153** dated **18.04.2019** vide Result Notice No. **386** dated **23.03.2019** and accordingly an Offer of Appointment was issued to him vide this Directorate Memorandum dated **16.07.2019**, the second and third opportunity were given to him vide public Notices dated 27/09/2019 and 26/10/2019 published in the leading newspapers and Final Opportunity vide Memorandum dated **18.11.2019**.

3. As per DoPT Office Memorandum NO. 35016/2/93-Estt.(D) dated 09/08/95 wherein para 2, the following has been mentioned:

"An Offer of Appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond three months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only up to a maximum period of six months from the date of issue of the original offer of an appointment. **An offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment.**

Therefore, In view of the facts and circumstances as above and since the candidate has willfully chosen not to respond to the above mentioned memorandums, this tantamounts to refusal to accept offer of appointment. Therefore, the candidature in respect of **Mr./Ms. NISHAN SINGH** is hereby cancelled and the dossier returned to the DSSSB.
