



2. As per DoPT Office Memorandum NO. 35016/2/93-Estt.(D) dated 09/08/95 wherein para 2, the following has been mentioned:

"An Offer of Appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond three months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only up to a maximum period of six months from the date of issue of the original offer of an appointment".

Therefore, In view of the facts and circumstances as above and since the candidate has willfully chosen not to respond to the memorandums dated 25-07-2019, public notice dated 31-10-2019 and 19-11-2019 the candidature in respect of **Ms. SHIKHA MOHINDRA** is hereby cancelled and the dossier returned to the DSSSB.
