On review, it is observed that some officials are not undertaking field visits to FPSs as mandated by the above orders. Non compliance of the orders shall be viewed seriously. Asstt. Comm. Of the districts are directed to ensure that necessary action is taken against defaulting FPSs as per extant orders in a time bound manner.

Special Commissioners are also advised to monitor enforcement activities in the districts under their supervision and ensure compliance of order.
