
**ORDER**

It has been observed that dumping of C&D waste / other municipal waste along the embankments of I&FC Department drains has become a constant phenomenon being faced by the department. In order to keep the territories of drains including the water way area neat and clean, it is important that constant vigil is maintained at all the drains. The issue of deployment of Civil Defence volunteers / Home Guards has been taken up with Divisional Commissioner, Delhi / Director General (Home Guards), but no concrete action plan in consultation with above-said offices has been submitted by any of the Executive Engineers. This has resulted in the delay of deployment of flying squad at various sensitive locations along the drains to prevent dumping of C&D waste / other municipal waste etc.

02. Recently, Chairman, EPCA has taken a serious view of the accumulation of municipal waste along the embankment of Trunk Drain No. I and suitable instructions were given for the removal of the same. There is a strong possibility that similar municipal waste / C&D waste has also been dumped / accumulated at the embankments of various drains of I&FC Department.

03. In view of the above, Secretary (I&FC) has directed to comply the following directions:-

- a) To ensure that all the drains where municipal waste / silt is accumulated / lying, shall be removed immediately in coordination with respective Municipal Corporation / DSIIDC / DDA / PWD, as the case may be.
- b) An action taken report thereof i.e. about the removal of C&D waste / municipal waste be furnished by 22/02/2019 on the enclosed format for kind perusal of Secretary (I&FC).
- c) Detail Action Plan of the deployment of Flying Squad at the focal points of dumping of C&D waste / municipal waste along the drains be worked out in consultation with the Divisional Commissioner Office / DMs and DG, Home Guards and submitted by 22.02.2019. Further, if meeting is required, the time thereof may be taken from the above office on priority.
