**MINUTES OF THE MEETING OF HEAD OF DEPARTMENTS/ LOCAL BODIES AND
POLICE NODAL OFFICERS HELD ON 12.02.2019 AT 12.30 PM AT CONFERENCE
HALL, OFFICE OF CHIEF ELECTORAL OFFICER, DELHI TO REVIEW POLL
PREPAREDNESS FOR THE ENSUING GENERAL ELECTION TO THE LOK SABHA, 2019.**

The list of participants is annexed.

At the outset, the Chief Electoral Officer, Delhi welcomed all the officers/participants in the meeting and explained the importance of this meeting as part of build up for the forthcoming Lok Sabha Election.

The proceedings of the meeting department wise are as follows :-

1. Delhi Police :-

- (i) Delhi Police submitted that they have already prepared **CPMF requirements** for the forthcoming Election and sent the same to CEO Office. **(107 Coys. Of CPF requirement has been assessed).**
- (ii) They have worked out the deployment plan of Security forces. CEO, Delhi requested to **submit the draft Security Deployment Plan latest by 20.02.2019.**
- (iii) Vulnerable and Critical Polling Stations is to be prepared jointly with the Sector Officers / Magistrates. CEO, Delhi has desired that this task of identification of critical polling stations and vulnerability mapping should be carried out and the list of such polling stations be prepared by 20.02.2019 so that preparation for webcasting and other required venues of these polling stations can be planned & completed at the earliest.
- (iv) Delhi Police informed that in the last election, **around 4000 Homeguards from Delhi** and 11,000 from other states were deployed and this time also same numbers will be required to be deputed.
- (v) It was also informed that the communication plan for the state is under preparation and will be completed soon. CEO Delhi desired that the Plan should be expedited and submitted to CEO Office latest by 25.02.2019.
- (vi) It was also informed that no satellite phones would be required and however, 900 VHF handsets will be required in addition to existing handsets and for that a request letter has been sent to MHA and CEO office to allow them to retain **about 900 wireless handsets** used during the last Republic Day.
