- (i) Bonded warehouses are hereby put under 24x7 CCTV monitoring.
- (ii) No liquor is released without proper license/permit.
- (iii) Atleast 15 minutes of recording of BWH shall be viewed by the designated Officer(Bond inspector) on daily basis in respect of each BWH under him/her.
- (iv) It will be ensured that CCTV camera footage are preserved for a period of minimum 60 days for all bonded warehouses
- (v) A certificate in the following format is to be submitted in this office on daily basis without fail:

"It is certified that all CCTVs, installed at the BWH are under proper working condition, there output is examined and no irregular activity regarding illicit storage or transportation of illicit liquor is noticed."
