The applicant sought the information under RTI Act, 2005 vide ID No. 14278.

The appellant filed an appeal on 21.12.18 under section 19 of the RTI Act, 2005 before the undersigned and submitted that no satisfactory reply received from the PIO.

In response to the appeal filed by the appellant, hearing notices were served on 08.01.19 to all the parties with request to appear before the First Appellant Authority on 18.01.19 with relevant documents.

Present Advocate Vineet Yadav, appellant in person and submitted that the reply by the PIO is not satisfied.

Shri Pramod Kumar, ASO on behalf of PIO(Alt.) submitted that the applicant was requested to inspect the concern file and information was provided.

applicant seeks the information as per record available and sought relief under section 18 and 20 of the RTI Act, 2005 and relied on the judgment of the

Central Information Commission vide W.P. (c) No. 6755/2012. The power under these sections is vested with the Central Information Commission and it is beyond the jurisdiction of First Appellate Authority and accordingly it is rejected.

However, PIO(Alt) is directed to allow inspection of the concern file/record to the appellant on mutually convenient date and provide the complete information as available on record, on the basis of inspection done by the appellant within 15 days of the receipt of this order as per provisions under the RTI Act, 2005.

Appeal is disposed of accordingly.

In case the appellant is not satisfied with the information provided above he can file 2<sup>nd</sup> appeal before the Second Appellant Authority i.e. Central Information Commission, Baba Gang Nath Marg, 3rd Floor, Munirka, New Delhi – 67.
