The applicant sought the information under RTI Act, 2005 vide ID No. 14355.

The appellant filed an appeal on 26.12.18 under section 19 of the RTI Act, 2005 before the undersigned and submitted that no reply received from the PIO till date.

In response to the appeal filed by the appellant, hearing notices were served on 08.01.19 to all the parties with request to appear before the First Appellant Authority on 18.01.19 with relevant documents.

Present Shri Munni Lal, appellant in person and requested to provide certain information regarding whether compensation has been paid or not to the owners of the Khasra numbers mentioned in the RTI ID No.14355 dated 24.09.18.


Shri Reshwani Kohli, ASO on behalf of PIO(LA) submitted that the said RTI forwarded to SDM (Mehrouli).

I have gone through the submission of both the parties, the information pertains to SDM (Saket) but inadvertently PIO (LA) forwarded his RTI SDM (Mehrouli). PIO (LA) is directed to forward the concern RTI application to

SDM (Saket) within 15 days of receipt of this order as per provisions under the RTI Act, 2005 as the payment detail is not maintained in the office of Land and Building Department.

Appeal is disposed of accordingly.

In case the appellant is not satisfied with the information provided above he can file 2<sup>nd</sup> appeal before the Second Appellant Authority i.e. Central Information Commission, Baba Gang Nath Marg, 3rd Floor, Munirka, New Delhi - 67.
