**Order under Para 2(B) of the PGC Resolution No F.4/14/94-AR dated 30.7.1998**

**1. Brief Facts of the Case**

The complainant has filed a complaint stating that he lodged a criminal complaint on 13.4.2018 against Shri Ram, Sumit and other son of Shri Ram for beating and molesting his wife Mrs. Kamlesh Goel to SHO/New Friends Colony. This complaint is regarding his shop bearing NO. 50/5, Masigarh village, Sukhdev Vihar, Delhi, which was illegally locked by Shri Ram and his two sons on 13.4.2018, when his wife on the same day requested them to let her go inside the shop and to check if no material is missing. They abused her and threatened her and did not allow her to enter the shop. Unhesitant of the threats, his wife moved forward towards the said shop, but as soon as she moved, one son of the alleged pulled his wife suit and other son held his wife's hand and pushed her and threatened to kill her if she tries to enter the shop. She got really scared and embarrassed on the said incident and called him (the complainant) in panic. He immediately called the Police at No. 100. Police reached the spot. He also approached other authorities, but despite the lapse of five months, no action has been taken on his complaint till date. He alleged the accused persons in connivance with the SHO has managed to evade prosecution for their criminal actions. He has requested for legal action in the matter.

**2. Facts emerged during the hearing**

2.1 SHO Rajesh Mishra from PS NFC is present and submitted action taken report. The same has been taken on record. He stated that he has obtained the PCR Form and statement of PCR staff too was recorded. Additionally, the alleged person too was also enquired. More

persons are still needed to be enquired and he is in the process of verifying the facts. He requested for more time to file a detailed report.

2.2 The complainant Shri M.C. Goel is present. He reiterated that his complaint is regarding misbehave with his wife by the alleged persons and not about the shop.

2.3 The Commission directed the SHO/NFC to go through the CCTV footage, statement of complainant's wife and take action accordingly and file status report in the matter by 26.12.2018.

2.4 SHO/NFC has now submitted a status report in the Commission on 1.1.2019 stating that after checking the CCTV footage minutely and discussing the matter with senior officers, a case vide FIR no. 328/18 u/s 354/506/509/34 IPC has been registered at PS New Friends Colony on the complaint of Ms. Kamlesh Goel and investigation of the same is under progress.

### **3. Directions of PGC**

In view of the foregoing discussion, the Commission decided to close the case.
