### **1. Background**

Sh. S.C.Bhaskar, the appellant, vide DRTI applications, has sought information from Deputy Commissioner (Civil Lines Zone), North DMC / the Competent Authority notified under the DRTI Act-2001, on total 22 counts.

The appellant is not satisfied with the reply received from the Competent Authority i.e. Deputy Commissioner (Civil Lines Zone), North DMC. Hence, he filed the appeals before the Appellate Authority, Public Grievances Commission under Section 7 of DRTI Act -2001.

### **2. Proceedings**

The applicant is present and heard.

Shri V.N.Roy, O.I. (B), Civil Lines Zone, North DMC and A.V.Sharma, AE (B), CLZ, NDMC, are present on behalf of the Competent Authority. They informed that

point-wise information has already been furnished to the appellant vide department's letter dated 29/01/2018. A copy of the same is available in the case files.

The department has provided information in respect of few queries but in most of the cases the appellant has been requested to inspect the relevant record on any working day, since the information sought is voluminous. The DRTI application submitted by Shri S.C. Bhaskar was perused and the Appellate Authority / PGC agrees with the view of the Competent Authority that the information sought is indeed voluminous. Hence, the appellant was advised to visit the office of the Deputy Commissioner (Civil Lines Zone), North DMC, to inspect the record and obtain photocopies of relevant documents.

### **3. Decision**

During the discussion today, it was mutually agreed that inspection shall be accorded to the appellant in Room No. 204 in the office of the Deputy Commissioner (Civil Lines Zone), North DMC, on **Monday, 24/09/2018 at 3:00 P.M.**

The Deputy Commissioner (Civil Lines Zone), North DMC, shall ensure that all the relevant record is made available to the appellant on the said date and time. Thereafter, photocopies of documents identified by the appellant shall be made available to him on payment of fees, as prescribed under DRTI Rules, 2001.

**With the above directions, the appeal stands disposed.**
