1. Background

The appellant did not receive any information from the Competent Authority i.e. Deputy Commissioner (Civil Lines Zone), North DMC. Hence, he filed the appeals before the Appellate Authority, Public Grievances Commission under Section 7 of DRTI Act -2001.

2. Proceedings

The applicant is present and heard.

Shri V.N.Roy, O.I. (B), Civil Lines Zone, North DMC and Shri A.V.Sharma, AE (B), CLZ, NDMC, are present on behalf of the Competent Authority. The departmental representatives informed that the appellant has been requested to inspect the relevant record and obtain photocopies of the relevant documents required by him. The appellant has also agreed for the same.

3. Decision

It is, therefore, directed that the appellant may be allowed to inspect the relevant record on a mutually convenient date and time. The date and time should be fixed by the Deputy Commissioner (Karol Bagh Zone), North DMC and intimated to the appellant, well in advance. It must also be ensured that all the relevant documents are available for inspection on the given date and time. Thereafter, photocopies of documents shall be given to the appellant on payment of fees, as prescribed under the DRTI Rules, 2001. The date may be fixed not later than 15 days of issue of this order.

With the above directions, the appeal stands disposed.
