1. Brief Facts of the Case

The complainant has filed a complaint stating that three ladies of her locality, namely, Panweshri, Usha and Kiran attacked to her life with bricks, as a result of which she suffered injuries. Her MLC was prepared in the Safdarjung Hospital. She also alleged that they are also involved in the illegal activities of theft of electricity, water theft from illegal boring, illegal building activities etc., etc. She further alleged that ASI Naveen and Vinay did not take any action on her complaint. The complainant has requested for registration of FIR on the basis of MLC and necessary action against erring police personnels.

2. Facts emerged during the hearing

2.1 Shri Parmod Kumar, ACP, South West District is present and submitted action taken report. The same is placed on file and shared with the complainant.

2.2 The police representative stated that result has been obtained on the MLC of the victim Nirmala Devi. The doctor has opined the nature of injury is 'simple blunt'.

2.3 The complainant is present and stated that she has been receiving threats from the alleged persons. She has lodged complaints against them with the local police.

2.4 She further requested the Commission to issue orders for opening of passage.

3. Directions of PGC

3.1 In case the submissions made by the complainant at para 2.3 above are correct, the SHO/PS Kapashera to take note of the same and ensure necessary police action including preventive measures.

3.2 The matter relating to opening of passage, the same falls within the purview of Revenue Authorities and police has nothing to do. Moreover, its reportedly pending with District Magistrate. Therefore, no further action is warranted in this matter.

3.3 With the above advice, the Commission has decided to close the case in PGC.
