### **1. Brief Facts of the Complaint**

The complainant has filed a complaint of inaction against Delhi Police. She has stated that her 11 year old son went missing from her home on 4.10.2017 for which FIR No. 904/17 was registered at PS Nand Nagri. She has alleged that the police has not taken any action to recover her son inspite of the fact that she had informed the police vide her another complaint dated 12.2.2018 that her son was abducted/lured by one of her neighbour Arjun Lal. She has requested for recovering her son.

### **2. Facts emerged during the proceedings**

2.1 Inspector Pawan Singh Rana from PG Cell/North East District alongwith ASI Idrish Khan is present and filed action taken report. A copy of the same is shared with the complainant.

1.2 IO of the case ASI Idrish Khan stated that HC Manoj Kumar has visited Bihar in search of alleged Arjun Lal Das on 3.2.2019. The local police too was associated to his house, where his mother and brother told that he has not come to village for the last 1 ½ years. The Mukhiya of village also verified that alleged Arjun Dass has not visited village in the last over 1 year

2.3. ASI Idris Khan further stated that details and photograph of missing boy were also shared with NGOs-Sathi, Rajender Nagar Delhi, My Home India, New Ashok Nagar, Village Cottage Home-I and III, Lajpat Nagar, Delhi with request to them to provide help in search of the missing. The record of the said NGOs were also checked but no clue so far.

2.4 The police report further stated that the alleged person is a patient of leprosy and did not visit his home town in last many years. Police teams have been sent to the village of the alleged on two different occasions in the last six months. The fact that he has not visited his home town/village has also been confirmed by the Mukhiya of the village.

## **2 Directions of PGC**

**2.1 Considering the efforts made by the police to trace the missing boy and the alleged person including assistance sought from the NGOs i.e. Sathi, My Home, the Commission notes that all possible efforts have been made by the police to trace the child and track the alleged person. The Commission therefore decides to close the case in the Commission with directions to police to continue investigation in AHTU, the specialized unit of the police. Further, all possible efforts to track the alleged person including tracking of child should be reviewed monthly by ACP incharge AHTU of the District.**
