**Order under Para 2(B) of the PGC Resolution No F.4/14/94-AR dated 25.9.97**

**1. Brief facts of the case:**

1.1 Shri Kela Singh, the appellant vide DRTI application dated 29.9.2014 had sought certain information regarding the land in Khasra No.406 from the Dy.Commissioner(Narela Zone), North DMC/Competent Authority notified under the DRTI Act, 2001.

1.2 Shri Ajit Kumar, EA(A) O/o. BDO (North) informed during the DRTI proceedings dated 16.7.2018 that the file relating to transfer of land to the local bodies is under process with the O/o. Divisional Commissioner-cum-Secretary(Revenue) for seeking clarification, as desired by CS, Delhi.

1.3 The Appellate Authority/PGC was of the view that all the queries posed by the appellant have been satisfactorily answered by the Competent Authority under DRTI Act, 2001. However, the Commission vide its order dated 16.7.2018

was of the view that the case may be taken up as *Suo-moto* grievance case and fixed for regular hearing to safeguard government land and to ensure that a government school for the benefit of the residents of the area is constructed on the piece of land, if feasible.

1.4 The case of the complainant is that the land i.e. Kh.No.406(4-4) in Village Mungeshpur, which belongs to MCD before the consolidation proceedings in 1986-87 may be used for a public purpose viz. construction of school or playground for children, before the same is usurped by the land grabbers.

## **2. Facts emerged during the proceedings.**

2.1 Shri Ajit Kumar, E.A.(Agr.), O/o. BDO (North), GNCTD filed copy of the handing over report of Khasra No.406 (4-4), Village Mungeshpur. As per this report, the above land has been handed over to Shri Khushi Ram, School Inspector, Education Department, Shri Krishanvir Singh, School Incharge, Boys School, Mungeshpur, Smt. Seema Rani, School Incharge, Girls School Mungeshpur and Shri Naveen Kumar, J.E, MCD in the presence of Shri Ajit Kumar, Panchayat Secretary, O/o. BDO(North), Shri Harindra Mohan, Field Kanungo and Shri Manoj Kumar, Halka Patwari, O/o. SDM(Narela), GNCTD. An inspection of the said Khasra was also done to the satisfaction of the representatives of Education Department, North DMC along with the revenue officials. It was further informed that no protest, whatsoever, was observed from any quarters during the handing over process of the said Khasra and the process was complete to the satisfaction of Shri Khushi Ram, School Inspector, Education Department, North DMC.

2.2 The complainant is not present during the proceeding today in the Commission.

## **3. Directions:**

3.1 Since the O/o. District Magistrate (North) has taken due action in handing over Khasra No.406(4-4), Village Mungeshpur to the Education Department, O/o. D.C.(Narela Zone), North Delhi Municipal Corporation and the same has been taken over by the Education Department, North DMC on 21.12.2018, the grievances of the complainant has been resolved. Hence the matter is closed in PGC.
