1 Background :

The appellant vide DRTI application dated 24.8.2018 has sought information on total 09 points. Aggrieved by non receipt of any information from the Competent Authority, he filed this appeal.

2 Proceedings

The appellant is present. Sh. Kishan Swaroop Singh, AO, Shahdara North Zone, EDMC is present on behalf of the Competent Authority. The representative of the department has furnished a letter dt. 11.2.2019 (in duplicate) vide which the department has provide point-wise information to the queries of the appellant. A copy of the reply was handed over to the appellant in the hearing today.

The reply has been perused and it appears that the department has provided satisfactory information in response to query no. 1 to 5, 8 and 9.

In response to query no. 06, the department has mentioned that no officer of the department is responsible for the illegal weekly markets in Nand Nagri/Sunder Nagri areas. This reply cannot be considered appropriate because, although the department may not be able to control such weekly illegal/unauthorised weekly markets, but the concerned officer Incharge of the area should be held accountable for these illegal weekly markets..

The information in respect of query no. 07 i.e. the details of shop owners and their addresses who were challaned by the MCD may be furnished by the department within a week's time. The Admn. Officer present in the hearing has agreed to provide the information within a week's time.

3 Decision

Since the Competent Authority i.e. Dy. Commissioner, Shahdara North Zone, East DMC has provided satisfactory replies to all the queries of the appellant, except for query no.7, no further action is required to be taken on these points.

In respect of query no. 7 the department shall furnish a revised information, as advised above, within 07 days of receipt of this order directly to the appellant with a copy marked to this Commission for information. The revised reply shall be issued under the signature/stamp of the Competent Authority.

With the above direction, the appeal case is disposed of at the Commission's end.
