1 Background :

The appellant vide DRTI application dated 8.6.2018 has sought information on total 07 points each. Aggrieved by non-receipt of information from the Competent Authority, he filed this appeal.

2 Proceedings

The appellant is not present. Sh. Ashish Sharma, AE (Bldg.) CSP Zone, North DMC is present on behalf of the department. The representative of the department informed that point-wise information has already been furnished to the appellant by the department vide letter dt. 30.7.2018. A copy of the same was submitted in the hearing today.

The reply has been perused and it appears that the department has furnished satisfactory reply to the queries of the appellant except for query no. 05. In query no. 05, the appellant has sought details of prosecution action under section 466/466 (A) of DMC Act along with copy of FIR. The information provided is not satisfactory. It is therefore directed that the relevant records may be checked and the prosecution action taken by the department, if any, shall be intimated to the appellant.

From the reply of the department, it is further observed that the property no. 1735, Nai Basti has been booked for unauthorised construction on 6.2.2017 and 10.11.2017. Though it is not a part of DRTI application, the department may intimate the Commission about the further action taken on the property, consequent upon the bookings.

3 Decision

Since the Competent Authority viz. Dy. Commissioner City/SP Zone, North DMC has furnished satisfactory reply to all the queries of the appellant, except query no. 05, no further information is required to be provided in respect of query nos. 1 to 4 and 6 & 7.

A revised reply in respect of query no. 05 and also further action taken by the department consequent upon the booking of the property, as discussed above, shall be furnished within 03 weeks from the date of issue of this order, directly to the appellant with a copy marked to this Commission. The reply shall be sent under the signature /stamp of the Competent Authority.

With the above direction, the present appeal case is ordered to be disposed in the Commission.
