1. Brief facts of the complaint

Shri Kawaljeet Singh filed a Complaint regarding illegal and unauthorized construction made by the owner of the property bearing No. 129-A, Pocket-I, Mayur Vihar and not taking action by the concerned building department officials of the EDMC and concerned PS Mayur Vihar

3. Relevant facts emerging during the hearing

3.1 Shri B.P.Dubey, Asstt. Engineer (B) is present in the hearing and submitted a report stating that Flat No. 129-A, Pkt.A, Mayur Vihar-I is booked for unauthorized construction on 15.01.18 for u/c in the shape of room, office beyond Standard DDA Plan and demolition order has been passed on 02.02.2018 after following the due process of law.

The said demolition order has been challenged by Sh. Lakhbir Singh in ATMCD and an interim stay has been granted by the ATMCD against the demolition order till next date of hearing, which has been fixed for 13.03.2019.

The property was inspected by concerned JE(B) and the status is same as submitted earlier and free access to shaft has been provided to all the occupants by removing door fixed at ground floor.

3.2 The owner of the property under complaint is also present in the hearing and informed that the complainant has also filed Court cases against him and has hidden the fact from this Commission.

4. <u>Directions of the PGC</u>

As the matter of complaint is sub - judice in Court of Law, the same stands closed at the level of this Commission.
