# Order under Para 2(B) of the PGC Resolution No F.4/14/94-AR dated 25.9.97

### 1. <u>Brief facts of the complaint</u>

Sh. Amrit Lal Aggarwal has filed a grievance in PGC on 23.10.2018 regarding nonpayment of arrears of 7<sup>th</sup> Pay Commission w.e.f. 01.01.2016.

## 2. <u>Proceedings in the Public Grievances Commission</u>

#### 3. Relevant facts emerging during the hearing:

3.1 Shri Mahendra Mishra is present from the SDMC HQ and submitted a reply which is same as was submitted earlier in the hearing held in the month of December, 2018.

The instant reply received from AO (Pension), SDMC has further mentioned about the policy of payment of pension to the retired employees and family pension to the family of the deceased employee. It does not serve any purpose as far as grievance of the complainant is concerned. The main issue in this case is the arrear admissible to the complainant under 7<sup>th</sup> CPC.

### 4. <u>Directions of the PGC:</u>

- 4.1 Dr. Puneet Goel, Commissioner, South DMC is advised to ensure that the matter is examined a fresh and a decision is taken so that atleast retired employees can be paid arrears of 7<sup>th</sup> CPC in installments.
- 4.2 Dy. Controller of Accounts (Final Payments), SDMC, is directed to examine the case a fresh so that atleast the retired employees can be paid arrears of 7<sup>th</sup> CPC in installments.

With the above directions the matter stands closed at the level of this Commission.
