1. Background

Shri Devendra Singh Tomar, the appellant vide his application dated 31/08/2018 under Delhi Right to Information Act, 2001, had sought information from the Competent Authority on 05 points. Being aggrieved with non receipt of any information, he filed this appeal before the Commission.

2. Proceedings

The appellant is present and heard.

Shri Shrikant Prasad, AE (B), West Zone, South DMC, is present on behalf of the Competent Authority. He informed that point-wise information has already been sent to the appellant by the department vide letter dated 17/12/2018.

However, perusal of the reply reveals that the information has been provided in respect of one Shri Praveen Dhawre, JE and Shri Shrikant Prasad, AE, posted in Ward 007S and 012S, whereas the appellant has sought information in respect of Shri Sunil Kumar-I, JE and Shri Shrikant Prasad, AE posted in Ward No. 006S. Therefore, the information provided by the department is not relevant to the queries of the appellant and hence, cannot be accepted.

3. Decision

In view of above, the Competent Authority viz. Deputy Commissioner (West Zone), South DMC, shall furnish a revised reply to the queries of the appellant. The revised reply shall be sent within 2 weeks of receipt of this order, under the signature / stamp of the Competent Authority, with a copy marked to this Commission for information.

If the appellant is to be called for inspection of records, in response to any query, then the date and time should be intimated to him well in advance. It should further be ensured that complete record is made available to the appellant on the date and

time fixed for the same. Thereafter, copy of documents, identified by the appellant, after inspection of relevant records, shall be provided to him, on payment of prescribed fee, in accordance with the provisions of Delhi Right to Information Act & Rules, 2001.

With the above direction, **this appeal case is ordered to be closed before the Appellate Authority / PGC.**
