1. Background

Shri Sunil Kumar Sharma, the appellant vide his applications dated 05/06/2018 under Delhi Right to Information Act, 2001, had sought information from the Competent Authority on 9 points. Being aggrieved with non receipt of any information, he filed these appeals before the Commission.

2. Proceedings

3. Decision

Since the department has provided satisfactory information to the queries of the appellant, no further action is required to be taken, except for query no. 4, in which inspection of relevant documents shall be accorded to the appellant. **The Deputy Commissioner (Civil Lines Zone), North DMC, shall fix a date and time for inspection, which shall be intimated to the appellant in writing well in advance. Thereafter, copies of documents, identified by the appellant, after inspection of relevant records, shall be furnished to him, on payment of prescribed fee, in accordance with the provisions of Delhi Right to Information Act & Rules, 2001.**

With the above direction, **these appeal cases are ordered to be closed before the Appellate Authority / PGC.**
