1. Brief facts of the complaint

3. Relevant facts emerging during the hearing

Sh. S.P. Bhaduri, S.O. is present in the hearing and submitted a Status Report stating that the amount of Gratuity i.e. Rs. 8,00,960/- and Commutation of Pension i.e. Rs. 4,48,180/- have been paid to the complainant on 28.08.2015.

The bills of Difference of Leave Encashment i.e. Rs. 50,240/-, MACP/Pay difference arrear i.e. Rs. 63,664/-, Difference of Gratuity i.e. Rs. 33,396/- and Difference of Commutation i.e. Rs. 5,900/- have been passed and lying pending in demand. The payment of the same shall be released as soon as the funds are available with EDMC.

4. Directions of the PGC

The major payments of terminal benefits i.e. Gratuity and Commutation of Pension (Rs. 8,00,960/- and Rs. 4,48,180/-, respectively) have been paid to the complainant. Remaining payments are related to difference / arrears have been approved and will be paid to the complainant subject to availability of funds with EDMC.

Sh. Sunil Tripathi, Asstt. Commissioner, Shahadara South Zone, EDMC is advised to ensure that all remaining payments are paid to the complainant in full, on availability of funds. An Action Taken Report in the matter may be submitted to this Commission.
