1. Brief facts of the complaint

Smt. Krishna Devi filed a grievance in PGC on 19.06.2018 regarding non release of Family Pension to her after the death of her husband who worked as Peon.

3. Relevant facts emerging during the hearing

3.1 Sh. Md. Quamar Ahmad, AAO, from the O/o Accounts Officer (Pension) is present in the hearing and submitted a report stating that the letter for start of family pension has already been sent to bank on 03.01.2019 and as per the bank scroll her family pension is being disbursed.

3.2 A report has been received from the Addl. Director, Ayurveda stating that the bill for DCRG has been passed by the AO (H&P) with final terminal benefits for Rs. 3,44,129/- in favour of the wife and two sons of the deceased. The same has not been paid till date due to financial crunch. 3.3 Complainant's representative present in the hearing informed that the DLI & arrear of family pension have also not yet been received.

4. <u>Directions of the PGC</u>

4.1 Dr. Raj Mann, Addl. Director, Ayurveda is advised to ensure that remaining payments i.e. DCRG & DLI are paid to the complainant on priority and an Action Taken Report is submitted to this Commission.

4.2 Sh. M.B. Ramesh, Dy. Controller of Accounts (Final Payment), North DMC is advised to take note of para 3.3 above and ensure that arrears of family pension are disbursed to the complainant in a time bound manner and an Action Taken Report is submitted to this Commission.

With the above directions in the matter the case stands closed at the level of this Commission.
