1 Background :

The appellant vide DRTI application dated 26.9.2018 has sought information on total 15 points. Aggrieved with non receipt of any information from the Competent Authority, he filed this appeal.

2 Proceedings

The appellant is present. Sh. Ankur Tyagi AE (Bldg.), CSP Zone, North DMC is present on behalf of the respondent department. The representative of the department informed that point wise information has already been furnished to the appellant vide letter dt. 25.3.2019. He submitted a copy of the same in the hearing today.

The reply has been perused and it appears that the department has provided satisfactory information to all the queries of the appellant, except for query nos. 5, 6, 9, 13 and 15.

Though these queries, the appellant has sought information regarding the details of educational qualifications, posting, promotion orders etc of all the Junior Engineers posted in the Building department of CSP Zone and also inspection of misilband register and construction watch register and complaints received from police and control rooms separately since 1.1.2017. The department has informed that this information is not available in the zone and pertains to Engineering (Headquarter), North DMC. This reply of the department is not satisfactory since this is available in the service record of the officials. Therefore the same can be compiled from the service record and made available to the appellant. In response two query nos. 13 and 15 the departmental representative has volunteered that the appellant can inspect the relevant records on any working day.

3 Decision

In respect of query nos. 5, 6, and 9, the Competent Authority i.e. Dy. Commissioner, CSP Zone, South DMC shall furnish a revised reply as advised above. The revised reply shall be sent directly to the appellant under the signature and stamp of the Competent Authority with a copy marked to this Commission for information.

As regards query nos. 13 and 15, it is directed that the Competent Authority shall accord inspection of relevant records to the appellant within two weeks of receipt of this order. The date and time fixed for inspection shall be intimated to the appellant well in advance. Thereafter copies of documents sought by the appellant shall be provided to him after payment of fee as prescribed under the DRTI Rules 2001.

With the above direction, the present appeal case is ordered to be closed in the Commission.
