1 Background:

The appellant vide DRTI application dated 26.9.2018 has sought information on total 14 points. Aggrieved with non receipt of any information from the Competent Authority, he filed this appeal.

2 Proceedings

The appellant is present. Sh. Sanjay Kumar JE (Bldg.), KP Zone, North DMC is present on behalf of the respondent department. The representative of the department informed that point-wise reply has already been sent to the appellant vide letter dt. 15.11.2018. He submitted a copy of the same in the hearing today. A copy of the reply was given to the appellant also.

The reply of the department has been perused and it appears that the department has provided satisfactory information to all the queries of the appellant. However in response to query no. 4, the department has informed that the service book and personal file of Sh. R.K. Jain, AE, Sh. Sunil Mohan Gupta, Sh. Raja Ram Meena and Sh. Mukesh Meena JEs are not available with this office. This may be checked and if the service records of these officials are available in some other office, then it may be clearly intimated. If the service records are available in KP Zone then the relevant information relating to these officials may also be provided.

Moreover, in response to the query nos. 3 and 13, the department has volunteered that the appellant may inspect the relevant records on any working day and obtain photocopies of documents.

3 Decision

The Competent Authority i.e. Dy. Commissioner, KP Zone, South DMC shall furnish a revised reply in respect of query no. 04 as observed above. The revised reply shall be sent under the signature/stamp of the competent Authority directly to the appellant within 10

days of receipt of this order. A copy of the same shall be submitted in this Commission for information.

Further the appellant may be accorded inspection of relevant records in response to query nos. 3 and 13 as mentioned above. The inspection may be accorded within 15 days receipt of this order after intimating the date and time to the appellant well in advance. Thereafter photocopies of documents selected by him shall be provided on receipt of fee as prescribed under the DRTI Rules 2001.

With the above direction, the present appeal case is ordered to be closed in the Commission.
