Since the parties involved in the Appeals are common, various Appeals are being clubbed together for hearing and disposal to avoid multiplicity of the proceedings and effective adjudication.

1 Background :

The appellant vide DRTI application dated 14.11.2018 has sought information on total 14 points each. Aggrieved by non receipt of any information from the Competent Authority, he filed these instant appeals.

2 Proceedings

The appellant is present. Sh. R. K. Sethi, AE (Bldg.) K.B. Zone, North DMC is present on behalf of the department. The representative of the department informed that point wise information has already been sent to the appellant by the department vide letter dated 13.12.2018. He submitted a copy of the same in the hearing today.

The reply of the department has been perused. The information provided by the department cannot be considered satisfactory since the department has provided a very general and vague information to the queries of the appellant, inspite of the fact that the appellant has sought information in respect of specific property in each of his DRTI applications. They have provided a combined reply to all the DRTI appeals of the appellant which is not correct.

However, the department has volunteered that the appellant can inspect the available record on any working day. Accordingly in the hearing today the departmental representative and the appellant have mutually fixed the date and time for inspection of records on 7.6.2019 from 2.00 P.M. onwards. Sh. R.K. Sethi, A.E (Bldg.) (Ward No. 103) shall co-ordinate with his counterparts in another wards to make available the relevant records pertaining to other wards in K.B. Zone.

3 Decision

The Competent Authority i.e. Dy. Commissioner, K.B. Zone, North DMC shall furnish a revised reply in respect of each appeal separately, specifically mentioning the property nos. in each case. The revised reply shall be sent directly to the appellant within 03 weeks of issue of this order, under signature/stamp of the Competent Authority, with the copy marked to this Commission for information.

It is further directed that all the relevant records shall be made available to the appellant for inspection on the date and time fixed for the same. Thereafter photocopies of documents identified by the appellant shall be provided to him on payment of requisite fee as prescribed under the DRTI Rules 2001.

With the above directions, all the appeal cases are ordered to be disposed of at the Commission's end.
