### **1 Background :**

The appellant vide DRTI application dated 23.3.2018 has sought information on total 16 points. Aggrieved by non receipt of any information from the Competent Authority, he filed this appeal.

### **2 Proceedings**

The appellant is not present. Sh. P.K.Chauhan, AE (Bldg.-1) Rohini Zone, North DMC is present on behalf of the department. The representative of the department submitted a letter dt. 19.6.2019, vide which the department has informed about the action taken as directed by the Commission on the last date of hearing. It has been informed that demolition orders passed against property no. F-17/7-8, Sector -8, Rohini and demolition programme was fixed on 30.5.2019 but could not be executed due to non availability of police force. Demolition action was taken on 14.6.2019, during which demolition action on roof slab of 3<sup>rd</sup> floor and reinforcement was cut by gas cutter. Photographs have been submitted as a proof of demolition action carried out by the department.

The reply of the department has been perused and it appears that the department has taken satisfactory action as directed by the Commission on the last date of hearing.

The Appellate Authority observes that the appellant had sought information related to two properties viz. F-17/7-8 and F-17/77-78, Sector -8, Rohini, Delhi. Whereas appropriate action has been taken against one property, however the department has not intimated any action taken against the latter property.

### **3 Decision**

The Competent Authority viz. Dy. Commissioner, Rohini Zone, North DMC is advised to take appropriate action under the DMC Act 1957 against property no. F-17/77-78, Sector -8, Rohini in case any unauthorised construction is noticed. An Action Taken Report shall be submitted in the Commission for perusal within 03 weeks of receipt of this order.

With the above direction, the present appeal case is ordered to be disposed at Commission `s end.
