1. <u>Brief facts of the case.</u>

1.1 The complainant has filed a grievnace in the Commission regarding re-fixation of his pension according to Wage Revision Committee report headed by Justice (Retd.) S.N. Aggarwal.

1.2 Several hearings here held in the Commission starting from 16.1.2018.

2. Facts emerged during the proceedings.

2.1 Ms. Payal Mahajan, Sr.Manager, BSES YPL filed an action taken report and the same is taken on record. As per the ATR, BSES Yamuna Power Ltd. has released a sum amounting to Rs.1,12,491/- on 03.06.2019 to Shri Bhagat Ram, being the remaining 50% of arrears payable to him (Total amount paid Rs.2,24,982/-). It was further stated that Shri Bhagat Ram himself has withdrawn the case filed before PGC . Hence, it was requested to close the matter.

2.2 Shri Bhagat Ram, complainant is not present today. However, a letter dated 07.5.2019 from Shri Bhagat Ram, complainant(herein) has been received in this Commission on 08th May, 2019 (Dy.No.1931) wherein he has prayed for withdrawal of his grievance application from this Commission and stated that his application be treated as withdrawn.

3. <u>Directions</u>

3.1 In view of the submissions made by the Sr. Manager, BSES YPL today in the Commission and in view of the fact that Shri Bhagat Ram, complainant has requested

for withdrawal of his grievance case from this Commission, the same is allowed. The case of the complainant stands closed in this Commission.
