1. Brief facts of the complaint

Ms Salina Daphne Gupta has filed a grievance regarding grave harassment due to deep nexus of Mr. Suraj Prakash, AE (B) and Mr. Prakash Arya, JE (B), North DMC with Mr. Kamal Ratawal, Local Builder.

3. Relevant facts emerging during the hearing

3.1 Sh. S.K.Singhal, Asstt. Engineer (B), Karol Bagh Zone is present in the hearing and submitted a report stating that a demolition program was fixed on 10.07.2019 under the jurisdiction of P.S. Parshad Nagar. During the action walls and reinforcement of column at 4th floor was demolished and reinforcement was also cut.

Further submitted that a Court Case titled “Ms Saleena Daphne Gupta Vs North DMC and others” is pending adjudication before

the Hon'ble Court of Sh. Ankit Singla. Next date of hearing in the matter is 27.08.2019.

3.2 The complainant present in the hearing was satisfied with the action taken by the Building Department.

4. Directions of the PGC

As the Action on the grievance of the complainant has been taken by the concerned officers of Building Department, Karol Bagh Zone the matter stands closed at the level of this Commission.
