1. Brief facts of the case:

1.1 Shri Tara Singh Mehra has filed a grievance petition before Public Grievances Commission, aggrieved by non-receipt of his Gratuity, salary of 62 months, leave encashment, unpaid bonus for the period he has served with M/s. Tritonics India Private Limited, Patparganj Industrial Area, Delhi.

2. Facts emerged during the proceedings

2.1 Shri Som Dutt Sharma, Asstt. Labour Commissioner, GNCT of Delhi present on behalf of respondent Labour Department and filed a report which has been placed on record. He stated that on 22.7.2019, representative of Management of M/s. Tritonics India Pvt.Ltd. had appeared along with complainant workman, Shri Tara Singh Mehra in Labour Department. The Management of the Company has agreed and paid Rs.1,67,781/-, as full and final payment which includes Gratuity, Leave Encashment, due wages and unpaid bonus, by way of 05 cheques, as per details mentioned below:-

1. 168411 Rs.28,949/- dated 26.7.2019.

2.	168412	Rs.34,037/-	dated 02.8.2019
3.	168413	Rs.34,655/-	dated 09.8.2019
4.	168414	Rs.35,000/-	dated 16.8.2019.
5.	168415	Rs.35,140/-	dated 23.8.2019.

It is further stated that the above said cheques were received by the workman, Shri Tara Singh Mehra himself.

2.2 The complainant is not present today nor has sent any intimation regarding his absence in the Commission.

3. Directions

3.1 Considering the submissions and report filed by the Asstt.Labour Commissioner, GNCT of Delhi, the Commission believe that all outstanding payments, as mentioned in the complaint, have been received by the complainant and no further action is pending on the part of the respondent department.

Hence, the case of the complainant stands disposed of and accordingly the matter is closed in the Commission.
