## 3. <u>Relevant facts that emerged during the hearing</u>

Sh. Sandeep Kr. Jain, AE(B), Shahadara North Zone is present in the hearing and submitted a report stating that "a programme was fixed with PS-Usmanpur on 27.08.2019 for taking action against the unauthorized construction at property no. F-17(Part), Gali No. 10, Brahmpuri, Delhi. On scheduled programme on 27/08/2019, the seal at main entry of the property was found tampered, therefore, the property has been resealed completely after taking part demolition action at the terrace of the property. The FIR has been lodged against the owner/occupier for tampering with seal vide letter no. DC/SH- N/2019/D-235 dated 27/08/2019. Further action shall be taken as per DMC Act in due course of time."
