1. Brief facts of the case

1.1 Sh. Mahinder Singh Anand has filed a grievance petition before Public Grievances Commission on 10.10.2018, aggrieved by non payment of pensionary benefits /crediting of 30 ELs.

2. Facts emerged during the proceedings.

2.1 Shri Devender Kumar, Vice Principal of Govt. Co.Ed.Sr.Secondary School, Singhu, Delhi, is present and filed a report. The same has been taken on record. It states that eighteen (18) E.L. has been granted to Shri M.S. Anand, retired, Vice-Principal against work done during vacations for Thirty Five (35) days as per CCS Rules in 2005-2006. A bill of Rs.17,136/- has been submitted to PAO-IX on 4.9.2019 for payment and the payment will be credited in the complainant' s account shortly.

2.2 The complainant is not present. He could not produce copy of order with regard to his officiating as Head of School for one complete session. It is also noted that no record in this regard is present in the

present School nor could it be traced and is not available with GBM School, Shahbad Dairy, Delhi, where the complainant had earlier served.

3. Directions:

3.1 Considering the fact that the respondent department has taken due action in resolving the grievance of the complainant with regard to payment in respect of the work done during vacations as per CCS Rules in 2005-2006 along with other grievances as mentioned in his complaint, the Commission believes that the grievances of the complainant has been resolved. Hence, the case of the complainant stands disposed of in the Commission.
