1. Brief facts of the complaint

1.1 Smt. Uma Suryanarayan has filed a grievance petition before Public Grievances Commission, aggrrieved by non-receipt of 6th CPC revised salary and pension and revised pension as per 7th CPC revision fitment table.

2. Facts emerged during the proceedings.

2.1 Ms. Anitma Jain, AAO of the respondent department filed a report which has been taken on record. It states that the case of Smt. Uma Suryanarayan was sent to Pay & Accounts Office No.07 on 26.8.2019 to examine the matter regarding pay fixation at the time of her promotion as Education Officer i.e. 23.11.2005. The Pay & Accounts Officer, PAO-07, GNCT of Delhi, has submitted that no pay fixation is required to be done at this stage if no option was exercised within one month of her promotion i.e. 23.11.2005 and pension so fixed is correct.

As per Personal File of the officer concerned, no option has been received from the officer for fixation of her pay.

2.2 Report of Pay & Accounts Officer-7,GNCTD is also on record wherein PAO-7 stated that the matter is to be examined by the Department concerned and if the

incumbent has exercised option to fix her pay from the date of next increment within one month of her promotion orders, then accordingly her pay is to be refixed and after releasing arrears due, revised LPC and revised Form-7 & calculation sheet is to be submitted in PAO, if due, otherwise no pay fixation is required to be done at this stage (if no option was exercised within one month of her promotion i.e. 23.11.2005) and pension fixed is correct.

2.3 The complainant is not present despite wait and repeated calls.

3. <u>Directions :</u>

3.1 In view of the submissions of the Pay & Accounts Officer No.-7, GNCTD and AAO, District West-B, Dte.of Education, GNCTD, it is noted that the case of the complainant has been examined thoroughly. Hence, the case of the complainant stands disposed of in this Commission.
