1. Brief facts of the complaint

Sh. Rajesh Sethi had filed a grievance in PGC on 18.04.2016 regarding unauthorized construction and encroachment in Suraksha Enclave, Parwana Road, Pitam, Pura, Delhi.

2. Proceedings in the Public Grievances Commission

The PGC has convened four hearings since 11.07.2016 and in the last hearing held on 17.04.2018 the orders of the Commission were :

“The complainant is directed to submit a copy of order of the ATMCD issued in the hearing of 3rd May, 2018 to inform the Commission about the status of the case. The matter is kept in abeyance till that time.”

3. Relevant facts that emerged now

The complainant vide his letter dated 23.09.2019 has informed that the matter is still pending at ATMCD and the next date of hearing is fixed as 29.01.2020.

4. Recommendations of the PGC

4.1 As the matter is still pending at ATMCD and the next date of hearing is 29.01.2020 Ex. Engineer (B)-I, Rohini Zone is advised to take further necessary action in the matter as per orders of the ATMCD and as per provisions of the DMC Act.

4.2 Sh. A.Gopikrishna, Deputy Commissioner, Rohini Zone is advised to ensure that further necessary action in the matter is taken by the concerned officers as per orders of the ATMCD and as per provisions of the DMC Act.

With the above recommendations the matter stands closed at the level of this Commission.
