1. Brief facts of the complaint

1. Shri M.L. Sagar, has filed a grievance petition before Public Grievances Commission on 23.10.2018, aggrieved by non revision of pension of pre-2006 and pre-2016 pensioners (PPO No.70250-02-00156). It is further stated that he is yet to receive any enhanced pension as per Central Pay Commission recommendations of 2006 and 2016.

As per CPC-2006, as decided by the Government, the revised pension shall be 50% of minimum of pay band plus grade pay. He requested to revise his pension in accordance with the GOI O.M. dated 28.1.2013 w.e.f. 1.1.2006.

2. Facts emerged during the proceedings.

2.1 The complainant, Shri M.L. Sagar, has authorized Shri Raj Kumar Sagar, his son, to attend the hearing on his behalf due to ill-health.

- 2.2 A report has been filed on behalf of HOS, Rajkiya Sarvodaya Kanya Vidyalaya No.2 stating that as the School has done all the work, now action is to be taken by PAO-XV.
- 2.3 Shri Mukesh Pathak, Pay & Accounts Officer No.15, GNCTD is present and filed a status report stating that two authorities were issued regarding revision of pension as per 7th CPC vide No.702500200156N1 dated 25.6.2019 & as per 6th CPC vide No.PAO15/PN/2019-20/2876-78 dated 20.8.2019 in respect of Shri M.L.Sagar, Gr.(DASS), Retd. but the same was received back from CPAO on 09/09/2019 with the remarks that "Manual SSA may be forwarded in the prescribed Format under Special Seal with Authorised Signatory for revision of pension."

Now, Pay & Accounts Office No.15 has also issued the manual SSA in respect of Shri M.L. Sagar in prescribed Format on 30/09/2019 and sent to CPAO.

2.2 Shri Mukesh Pathak, Pay & Accounts Officer No.15, GNCTD assured that he will personally coordinate with CPAO and ensure that the file is cleared within a week's time positively from CPAO for onward transmission to the bank's headquarter.

3. Directions:

- 3.1 Head of School, Rajkiya Sarvodaya Kanya Vidyalaya No.2, Jama Masjid, is advised to coordinate personally with the Pay & Accounts Office No.XV, GNCTD, and ensure release of the arrear of pension within one week's time from today.
- 3.2 Shri Mukesh Pathak, Pay & Accounts Officer No.XV, GNCTD is directed to pursue the matter at his level with CPAO and ensure clearance of case from CPAO within one week positively, as assured by him. A compliance report be sent to the Commission. He is further directed to extend cooperation to the complainant as and when he approaches him.
- 3.3 Pay and Accounts Officer, Central Pay Accounting Office, Ministry of Finance, Government of India is advised to revise pension of the complainant, in accordance with GOI OM dated 28.1.2013.
- 3.4 The complainant is advised to get in touch with Pay & Accounts Officer No.XV, GNCTD and the Principal of the School, for release of arrears of pension.

On receipt of the same, he may intimate the Commission in writing so that the matter could be disposed of in PGC.

3.5 With the above observations, the case stands disposed of in the Commission.
