1. Brief facts of the case

1.1 Sh. Sri Bhagwan filed a grievance petition in PGC on 02.11.2015 stating that his father was allotted agricultural land in Village Rawta, during consolidation proceedings. He was allotted same land, which was in his possession, as Bhumidar, even prior to consolidation. But some portion of this land was withdrawn by the Consolidation Officer, though there was no objection from anyone, within the prescribed period of limitation. Due to withdrawal of this land, his land was fragmented. Against this order of withdrawal dated 11.11.2003, the complainant filed two appeals in 2004, but till date, even after lapse of 11 years, the appeals are still pending, without any effective hearing. The complainant prayed for directions to the Settlement Officer / SDM (Kapashera), Revenue Department, GNCTD, to decide the appeals in a time bound manner.

2. Facts emerged during the proceedings:

2.1 Shri Amarnath K, Naib Tehsildar(Kapashera), GNCT of Delhi, filed an ATR forwarded by SDM (Kapashera), GNCT of Delhi, vide which it has been intimated that necessary changes in respect of land bearing Kh.No.17//15/2, 17//15/1 & 17//5/3, situated in the revenue estate of Village Rawta, New Delhi, have been made with the consent of Sh. Sri Bhagwan S/o. Shri Ran Singh and Shri Joginder Singh S/o. Shri

Randhir Singh r/o Village Rawta on 06.12.2018. They have also made necessary changes in the revenue records of Village Rawta under their signatures and hence the matter is settled and disposed of. Naib Tehsildar(Kapashera) also submitted revenue records to this effect incorporating necessary changes in the revenue records and also rough sketch of the land which is finally allotted in the names of the concerned bhumidhars.

2. **Directions**

2.1 Since necessary action has been taken on the grievances of the complainant by the respondent department, the matter is disposed of in the Commission.
