#### 1. Brief facts of the complaint

The complainant has filed a complaint of inaction and threatening against IO/HC Ashok, PS Mahindra Park. As per complaint, on 11.6.2018 at about 4.00 p.m. while she was going to Swaroop Nagar alongwith her friend Kaseem, she was forcefully dragged inside a car by Vijay and Sahil while Abhishek was driving the car. They put a piece of cloth on her mouth due to which she became unconscrious. When she regained consciousness she was at Nizamabad in Azamgarh (UP) alongwith the alleged boys. She was repeatedly raped by them and when she resisted they threatened to kill her. They even put a gun at her head. After 3-4 days Sahil and Vijay said that they will perform her marriage with Abhishek. She was raped continuously by Abhishek thereafter and her movements were restricted by Abhishek and his family.

On 1.7.2018, Delhi Police recovered her alongwith the alleged Abhishek and brought to PS Mahindra Park. Though she narrated her ordeal to the police but no case was registered on her complaint. On 16.10.2018, when the complainant alongwith her father went to the police station, police refused to register any case in the matter and demanded Rs. 5 lakhs for registering a case.

She has requested for legal action in the matter.

# 2. Facts emerged during the hearing

2.1 Inspector ATO Dhananjay Gupta is present and submitted an action taken report. He stated that on the statement of the complainant a case vide FIR NO. 574/2018 dated 19.12.2018 u/s 328/365/368/367D/506/34 IPC has been registered at PS Mahindra Park, North West District. The case is now under investigation.

### 3. Directions of PGC

- 3.1 IO is directed to arrest the alleged accused persons after bringing necessary evidence on record. He shall conclude the investigation in a time bound manner and file chargesheet/final report in the matter within the period specified under the law.
- 3.2 With the above advice, the Commission has decided to close the case in PGC.
