**ORDER U/S 35 (5) OF DCS ACT, 2003**

Whereas, Civil Supplies Co-operative Group Housing Society Ltd. (Regn. No.745/GH) is registered with this department under the provisions of DCS Act, Rules & Bye-laws framed thereunder;

And whereas, the tenure of the present Managing Committee of the society was expired on 26.12.2018.

As per section 35 (5) of DCS Act, 2003 says that: -


*35. Election and nomination of members of committee.*

*(5) Thereafter the committee shall arrange election of the new committee before the expiry of its term and in case the committee fails to do so, the committee shall cease to hold office on the expiry of its term and the affairs of the co-operative society shall be managed by an administrator appointed by the Registrar who shall also hold election within ninety days from the date of his appointment.*

Now, I Kulvendra Yadav, Assistant Registrar (Sec-II/GH) hereby conveys the approval of the Competent Authority to appoint **Mr. Hemant Kumar, Adhoc DANICS (Retd.)** as Administrator-Cum-Returning Officer under section 35 (5) of DCS Act, 2003 in Civil Supplies Co-operative Group Housing Society Ltd. (Regn No.745/GH) for the period of 90 days from the date of appointment of Administrator-cum-Returning Officer for conduct the election of managing committee of the society. The society will pay ₹.10,000/- (Rupees Ten Thousands only) per month as remuneration to the Administrator-Cum-Returning Officer from the society's funds.

The President/Secretary of the society is hereby directed to handover the charge of the record of the society/ relevant documents to the Administrator-cum-Returning Officer immediately under intimation to this office within 07 days from the issue of this order.


