And whereas on expiry of the tenure of Managing Committee on 09.01.2019, Sh. Vijay Singh was appointed as Administrator of the society under section 35(5) of DCS Act, 2003 vide this office order dated 27.02.2019.

And whereas, Sh. Vijay Singh, Administrator has expressed his inability to continue with the assignment and resigned from the post of Administrator vide letter dated: 27.03.2019.

And whereas, the society has filed petition before the Hon'ble High Court vide WP(C) No. 2282/2019 in the matter titled as "Ghalib Memorial CGHS Ltd. & Anr. Vs Registrar Cooperative Societies".

Whereas, as per the proceedings held in CWP No. 2282/2019 in Hon'ble High Court of Delhi on 28.03.2019 and vide letter No. 47/AR/163/GH/Sec-III/2019/6081 dated 29.03.2019. Returning Officer has been directed that the election process should be resumed from the stage where it was discontinued and election should be conducted on 07.04.2019 as per the list of members and the list of defaulters already published and displayed and at the same venue where it was earlier scheduled.
