ORDER UNDER SECTION 35 (5) OF DCS ACT, 2003

Whereas, Himachal Dhauladhar CGHS Ltd., is registered at serial No. 1363/GH with this department under the provisions of the DCS Act, Rules & Bye-laws of the society at Plot No.15, Sector-5, Dwarka, New Delhi-110075;

And whereas, the President of the society has informed this office vide letter dated 12.03.2019 that Mr. Alok Sharma, Returning Officer appointed by this office under section 35(1) of DCS Act, 2003 vide this office order dated 05.02.2019 has not contacted the society so far. The tenure of the Managing Committee of the society has already been expired on 27.02.2019 and requested this office to appoint an Administrator in the society to conduct the election of the Managing Committee of the society at the earliest;

And whereas, in view of the above circumstances, the Registrar Co-operative Societies has directed to appoint Mr. Bhanwar Singh, DANICS (Retd.) as Administrator-Cum-Returning Officer in the aforesaid society u/s 35(5) of DCS Act,2003 in place of Mr. Alok Sharma. Dy. Secretary, Land & Building, GNCTD.

Now, therefore, I, B.S. Thakur, Deputy Registrar (Housing), office of RCS, hereby convey the approval of the Registrar Co-op. Societies to appoint Mr. Bhanwar Singh, DANICS (Retd.) as Administrator-Cum-Returning Officer in the aforesaid society under section 35(5) of DCS Act, 2003 with remuneration of Rs.10,000/- (Ten Thousand Only) per month consolidated from the society's fund. The Administrator-Cum-Returning Officer conduct the election within a period of 90 days.

The other expenses of the election will be met out from the funds of the society. The election of Managing Committee of the aforesaid society shall be conducted as per the guidelines for the elections available in Rule-53 and of Schedule-II of DCS Rules, 2007.

Further the President/Secretary of the Society is hereby directed to handover the records/documents of the society to Administrator-Cum-Returning Officer within 07 days from the date of receipt of this order and extend full cooperation.
