## ORDER

Whereas, a meeting of the erstwhile office bearers of the Managing Committee of Himachal Dhauladhar CGHS Ltd. and Sh. Ishwar Das Sharma and Sh. Surjeet Singh was held in the chamber of the Registrar to discuss the issue of forthcoming election in the society which is required to be held as the period of the existing management committee has expired on 27.02.2019.

Whereas, the brief background of the case is that on a request received from the society, a Returning Officer Sh. Alok Sharma, Deputy Secretary, Land and Building department was appointed vide order dated 05.02.2019. However, Sh. Alok Sharma did not contact the society for conducting the election. The society contacted him on telephone but he expressed his inability/reluctance to conduct the election. On this the Management Committee wrote a letter to the RCS office on 12.03.2019 seeking the appointment of a new Returning Officer to conduct the elections.

Meanwhile, the other group issued a Special General Body Meeting Notice on 04.03.2019 to conduct a Special General Body Meeting on 17.03.2019. In the said meeting they constituted an Ad-hoc committee and decided to conduct the election on their own. However, on request of the society the RCS office issued order on 04.04.2019 appointing an Administrator-cum-Returning Officer in the society as the period of the MC of the society had expired on 27.02.2019. Meanwhile, the other group appointed a Returning Officer, who notified the Election agenda in which the date of election has been fixed for 28.04.2019.

Whereas, the matter was discussed by both the parties in the presence of Registrar and the parties gave their point of view to the Registrar and after discussions and in view of the facts and circumstances of the case, it was agreed that the schedule of election issued earlier will be adhered to by the newly appointed Administrator-cum-Returning Officer and the election will be held on the scheduled date of 28.04.2019. Now, the present Administrator-cum-Returning Officer shall issue a fresh agenda notice adhering to the schedule already notified and Election shall be held on 28.04.2019 as per earlier schedule.
