**ORDER U/S 35 (5) OF DCS ACT, 2003**

Whereas, Chitrakoot Dham Cooperative Group Housing Society Ltd. is registered with this department vide registration No. 897/GH under the provisions of DCS Act, Rules & Bye-laws framed thereunder:

And whereas, all the 07 members of managing committee have resigned (copy of resignations are enclosed). As per section 35(5) of DCS Act, 2003 says that: -

*"35. Election and nomination of members of committee.*

*(5) Thereafter the committee shall arrange election of the new committee before the expiry of its term and in case the committee fails to do so, the committee shall cease to hold office on the expiry of its term and the affairs of the co-operative society shall be managed by an administrator appointed by the Registrar who shall also hold election within ninety days from the date of his appointment."*

Now, I, Tanuj Bhanot, Assistant Registrar (Sec-II/GH) hereby conveys the approval of the Competent Authority to appoint **Mr. Anil Bhatnagar, SDM (HQ, South)** as Administrator-Cum-Returning Officer under section 35 (5) of DCS Act, 2003 in Chitrakoot Dham Co-operative Group Housing Society Ltd. (Regn. No.897/GH) to conduct the election of managing committee of the society within 90 days from the date of appointment as Administrator-cum-Returning Officer. The society will pay **₹.10,000/-** (Rupees Ten Thousands only) per month as remuneration to the Administrator-Cum-Returning Officer from the society's fund.

The President/Secretary of Chitrakoot Dham CGHS Ltd. is hereby directed to handover the charge of the record/relevant documents of the society to the Administrator-cum-Returning Officer immediately under intimation to this office within 07 days from the issue of this order.
