ORDER

Whereas, Fakhruddin Memorial Co-operative Group Housing Society Ltd. Plot No. 18, Sector-10, Dwarka, New Delhi-110075 is registered vide Registration No.582-GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

And, whereas, the present Managing Committee of the Society has been dissolved by its members vide letter dated 13.05.2019 (copy enclosed) and it is recommended by the MC members for the appointment of Administrator by the RCS office. The last election of the society was held on 30.07.2017 and for the financial year 2016-17 was conducted.

And whereas, Sh. Sandeep, Section Officer was appointed Administrator-Cum-Returning Officer of the Society vide order bearing no. F.No.47/ARH/582/GH/Sec-III/RCS/2019/197-201 dated 24.06.2019.

And whereas, Sh. Sandeep expressed his inability to take the duties of Administrator-Cum-RO in the above said Society and requested the Competent Authority to cancel the above said order and to appoint other officer as Administrator-Cum-RO at his place.

Now therefore, I, Ajit Kumar, Assistant Registrar (GH/Sec-III) hereby convey the approval of the Competent Authority to appoint **Sh. Suniti Kumar Gupta, Retd. Designated Officer, Food Safety Department in place of Sh. Sandeep, Section Officer, Directorate of Education** as Administrator-Cum-Returning Officer in Fakhruddin Memorial Co-operative Group Housing Society Ltd. (Regn. No.582-GH) under section 35 (5) of DCS Act, 2003 with immediate effect to conduct the election of the Managing Committee of the society within 90 days from the issue of this order and to attend day to day affairs of society. Administrator-Cum-Returning Officer will be paid 10,000/- (Rupees Ten Thousand Only) per month as honorarium from the society's fund for this purpose from the date of taking over the charge.
