ORDER

Whereas, the New Rajput CGHS Ltd, Sector-12, Plot No.23, Dwarka, Delhi-110078 is registered with this department vide Regn. No. 1236/GH under the provisions of DCS Act and Rules.

And whereas, an inquiry u/s 66(1) of DCS Act 2003 was instituted and Smt. Achla Singh (Now retired) was appointed Inquiry Officer u/s 66(1) on 02.11.2015.

And whereas, Smt. Achla Singh filed her report vide letter dated 30.09.2016 and the same was placed before the Competent Authority.
