ORDER

Whereas, the Climax Co-operative Group Housing Society Ltd. is registered vide registration No.560-GH with this department under the provisions of DCS Act, & Rules and bye-laws of the society;

And whereas, it is submitted, that representation was received from Ex-President/Secretary of the society wherein they have informed that *the election process, was observed and scrupulously complied with, by the society and the Returning Officer/Election Officer, but in the absence of any nominations from the members, no new Managing Committee, could be declared elected on the date of the election, 30.06.2019.*

They have further, stated that as the old Managing Committee, consisting and comprising of 07 members, stands dissolved and no new Managing Committee, has been formed, it is urged, to initiate expeditious appropriate action, for the smooth running and day to day monetary operations and Functions of the society.

Now, therefore, I, Gulshan Ahuja, Assistant Registrar/ Link Officer (Sec-II/GH) hereby conveys the approval of the Competent Authority to appoint Sh. J.P. Sharma, Retd. Assistant Director (Urban Development) as Administrator-cum-Returning Officer under Section 35 (5) of DCS Act, 2003 in Climax CGHS Ltd. at the remuneration of ₹.10,000/- (Rupees Ten Thousand Only) per month to be paid from the fund of the society who shall conduct election of the Managing Committee of the society within stipulated period 90 days from the date he assumes the charge as Administrator-cum-Returning Officer.

The President/Secretary of the Climax CGHS Ltd. is hereby directed to handover the charge and also the record/ relevant documents of the society to Sh. J.P. Sharma, Retd. Assistant Director (Urban Development) Administrator immediately under intimation to this office within 07 days from the issue of this order.
