Now, therefore, I, Amitabh Joshi, Assistant Registrar (T&C) hereby convey the approval of the Competent Authority to appoint Sh. Tapan Jha, Deputy Secretary (Land & Building Department) in place of Sh. S. Sunil, Superintendent, O/o Director General of Prisons as Administrator under Section 35(5) of DCS Act, 2003 at the remuneration of ₹10,000/- (Rupees Ten Thousand Only) per month to be paid from the fund of the society who shall conduct election of the Managing Committee of the society look into the complaints within stipulated period 90 days from the date he assumes the charge as Administrator.

President/ Secretary of the society is hereby directed to handover the charge and also the record/relevant documents of the society to Sh. Tapan Jha, Deputy Secretary (Land & Building Department) Administrator-Cum-Returning Officer immediately under intimation to this office within 07 days from the issue of this order
