ORDER UNDER SECTION 35 (1) OF DCS ACT, 2003

Whereas, Himalayan CGHS Ltd., is registered at serial No. 1249/GH with this department under the provisions of the DCS Act, Rules & Bye-laws of the Society at Plot No.10, Sector-22, Dwarka, New Delhi-110075.


And whereas, the President of the Society has informed this office vide letter dated 25.08.2019 that Sh. Pranjal Hazarika (DANICS), Returning Officer appointed by this office under section 35(1) of DCS Act, 2003 vide this office order dated 14.05.2019 has shown his inability to conduct the elections of the Society because he has been transferred outside Delhi.

The tenure of the Managing Committee of the Society has already expired on 14.08.2019 and the Society requested this office to appoint a Returning Officer to conduct the election of the Managing Committee of the Society at the earliest;

And whereas, in view of the above circumstances, the Deputy Registrar Co-operative Societies has directed to appoint Sh. S.K.S Yadav, DANICS (Retd.) as Returning Officer in the aforesaid Society u/s 35(1) of DCS Act,2003 in place of Sh. Pranjal Hazarika (DANICS) with remuneration of Rs.6,000/- (Six Thousand Only) per month consolidated from the Society's fund. The Returning Officer should conduct the election within a period of 90 days.

The other expenses of the election will be met out from the funds of the Society. The election of Managing Committee of the aforesaid Society shall be conducted as per the guidelines for the elections available in Rule-53 and of Schedule-II of DCS Rules, 2007.

Further the President/Secretary of the Society is hereby directed to handover the records/documents of the Society to the Returning Officer within 07 days from the date of receipt of this order and extend full cooperation.


