ORDER UNDER SECTION 61 OF DCS ACT, 2003

Whereas, the All Friends Co-operative (Urban) Thrift and Credit Society Ltd. registered vide registration No.20/TC dated October, 1998 with this department under the provisions of DCS Act & Rules framed there under;

And whereas, a complaint was filed by Sh. P. S. Jaswal, Mr. Santosh and many members of the society regarding corruption & misappropriation of funds by management committee of the society.

And whereas, Registrar Co-operative Societies after hearing both the parties and considering the submissions/ complaints regarding misappropriation of funds and mismanagement from various members as well as Directorate of Vigilance, GNCTD ordered that it is a fit case to order an inspection in this case and approved to appoint Sh. Soran Singh, Admn. Officer, Delhi (Minority Commission), GNCTD as Inspection Officer under section 61 of DCS Act, 2003.

Now therefore, I Amitabh Joshi, Assistant Registrar (T&C) hereby conveys approval of Competent Authority to appoint **Mr. Soran Singh, Admn. Officer, Delhi (Minority Commission)** as Inspection Officer under Section 61 of DCS Act, 2003. The society shall pay ₹. **10,000/- (Rupees Ten Thousand Only)** as remuneration to him from the fund of the society for holding the Inspection on the above allegations. The Inspection Officer shall complete the inspection and submit his report within 60 days of issue of this order.
