ORDER

Whereas, Jamna Bazar Co-operative Group Housing Society Ltd., Plot No.-28/2, Jamna Apartment, Sector -9, Rohini, Delhi-110085 is registered vide Registration No.1440-GII with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

And whereas, the Secretary of the Society has requested this office to appoint a Returning Officer as the elections of Managing Committee are due in the 3rd week of January, 2020.

And whereas, vide order dated 03.05.2019, the Registrar Cooperative Society has delegated powers to the Deputy Registrar for appointment of Returning Officer to conduct the election of the Society, except in cases u/s 35(5) and in cases where the power to appoint Returning Officer vests in Govt.

And whereas, in exercise of the powers vested under Section 35(1) of DCS Act, 2003, the Competent Authority has approved that the affairs of the society shall be managed by Returning Officer.

Now therefore, I, Ajit Kumar, Assistant Registrar (GII/Sec-III) hereby convey the approval of the Competent Authority to appoint Sh. M.L. Gupta (Retd. Adhoc DANICS) Returning Officer in Jamna Bazar Co-operative Group Housing Society Ltd. (Regn. No. 1440-GII) under section 35 (1) of DCS Act, 2003 to conduct the election of the Managing Committee as per DCS Act & Rules.

He will be paid Rs.6,000/- (Rupees Six Thousand Only) as remuneration from the society's fund for this purpose.
