And whereas Sh. M.C. Jha (Joint Director- Retd., Railway Board) was appointed as Administrator-cum-RO vide order dated 10.10.2019, who later expressed his inability to discharge his assignment due to his preoccupation.

Now therefore, I, Ajit Kumar, Assistant Registrar (GH/Sec-III) hereby convey the approval of the Competent Authority to appoint Sh. K.K. Satija, Deputy Director, Dept. of Welfare of SC/ST/OBC, GNCTD as Administrator-cum-Returning Officer in IFUNA Co-operative Group Housing Society Ltd. (Regn. No.84-GH) under section 35 (5) of DCS Act, 2003 with immediate effect to conduct the election of the Managing Committee of the society within 90 days from the issue of this order and to attend day to day affairs of Society.

He will be paid Rs.10,000/- (Rupees Ten Thousand Only) per month as honorarium from the society fund for this purpose from the date of taking over the charge. The previous order no F.No.47/ARH/84/GH/Sec-III/RCS/2019/460-465 dated 10.10.2019 issued by this office in favour of Sh. M.C. Jha (Jt. Director-Retd., Railway Board) stands revoked with the issue of this order.
